#### • Condition & Inspection

The vehicle shall be inspected at pickup and return. The renter agrees to return the vehicle in the same condition it was received. Any damage will be documented, and the cost will be deducted from the deposit or invoiced accordingly. Renter agrees to return the vehicle clean and in the same condition. A \$30.00 cleaning fee may apply if the vehicle is returned unclean.

#### • Photo Documentation Clause

For the mutual protection of both the Renter and the Lessor, photographs of the vehicle may be taken at the time of pickup and return. These images will serve as visual documentation of the vehicle's condition and may be used to verify any damages, cleanliness, or discrepancies noted during the rental period. The Renter is encouraged to take their own photos of the vehicle's exterior, interior, and gas gauge at pickup and return. Photos taken by the Lessor shall be considered valid evidence in the event of any disputes.

#### • Insurance & Liability

In case of an accident, the Renter agrees to pay for repairs not covered by insurance.

In the event of extensive damage requiring an insurance claim, the Renter agrees that any loss of 'No Claims Bonus' or insurance excess costs shall be borne by them.

#### • Breakdown & Emergency

In the event of a breakdown, the renter shall contact Maxx Taxi Tours immediately at 1 (784) 593-7656. Replacement or repair support will be provided as soon as possible.

#### Cancellation Policy

- 1. More than 72 hours' notice before rental start date: 100% refund of deposit.
- 2. Between 48 and 72 hours' notice: 50% refund of deposit.
- 3. Less than 48 hours' notice or No-show: No refund.
- 4. Early Returns: No refunds will be issued for unused days if the vehicle is returned before the end of the rental period.

#### • Termination

The Lessor reserves the right to terminate this agreement and retrieve the vehicle at any time due to breach of contract, unsafe operation, or non-payment.

#### Governing Law

This agreement shall be governed by the laws of St. Vincent and the Grenadines. Any disputes arising from this rental shall be resolved in the Magistrate's Court of St. Vincent.
